For insurance purposes, all participants must be current registered members in good standing and have signed waivers with both Rope Skipping Alberta Association (RSA) and Rope Skipping Canada (RSC) and be insured prior to the event. Please ensure the appropriate membership fees are included with the registration form.

FOIP - The Alberta Freedom of Information and Protection of Privacy Act requires that consent be obtained for collection and use of personal information. The information will be used for RSA Association administration, member communication, athlete interest for rope skipping competitions and workshops, compiling competition results (in all media formats) for club, Provincial and National records. All information collected from or pertaining to athletes will be kept private and confidential, unless authorized in writing by the athlete or parents (guardians) themselves. Activities that require your consent include, but not limited to:

1. Individual photos that are taken.
2. Photos or videos that are used in electronic or print media or social media
3. Athlete name, gender and/or age and description of activities (i.e. results) that are used in the newsletters and other communications in print form, electronic, social media or otherwise.
4. The use of athlete's name, gender, and age in team lists or databases to enable clubs to send data to other clubs, RSA Association and RSC.
5. Other activities within the rope skipping community.

Please note that photos and/or videos of activities that are open to the general public may be taken and used for purposes within and outside the rope skipping community. The Association may not have the capacity to restrict such activity at public events.

Please note that in following the RSC insurance policy and safety guidelines, RSA requires that all participants wear sport clothing that allows freedom of movement and will not pose a safety issue for the themselves or others, including wearing athletic shoes at all times at workshops and competitions. Additionally, wearing jewellery, gum chewing, eating/drinking while jumping is not permitted.
